Current Affairs Related to 26 December

- The International Monetary Fund said that India is estimated to contribute more than 16% to global growth. The International Monetary Fund also said that India is growing at a strong rate due to economic reforms in key areas such as digitization and infrastructure. India is on track to become one of the world's fastest growing major economies this year, according to Article IV.
- S&P Global Ratings reaffirms confidence in the credit strength of Asian emerging economies, expecting the credit ratings of APAC governments to remain stable for the next 1.2 years. S&P Global Ratings has expressed confidence in the credit strength of Asian emerging and developing economies, citing their positive impact on the credit ratings of governments in the Asia Pacific region. The agency estimates that these economies will contribute to maintaining stable credit ratings for most APAC countries over the coming one to two years.
- In a significant step towards addressing the critical issues of global warming and promoting sustainability education, research and outreach, Indian Institute of Technology Kanpur and Kotak have joined hands to establish the School of Sustainability. The collaboration aims to provide leadership solutions for sustainability and prepare future generations for sustainable development.
- India's National Pension System has achieved a remarkable 16.94% annual return on equity with assets worth Rs 10.7 trillion. Which is 25.95% more than last year. Driven by strong equity markets, the latest data from the Pension Fund Regulatory and Development Authority reveals remarkable insights into the performance and trajectory of NPS investments.
- With international crude oil prices stable below \$80 per barrel, demands for reduction in prices of gasoline and diesel have intensified.

- The Center said that a draft has been prepared in this regard. Information and Broadcasting Minister Anurag Singh Thakur said that the Broadcasting Services Bill 2023 will bring OTT content and digital news under its ambit. He also said that the Broadcasting Services Bill 2023 will streamline the regulatory process. It seeks to strengthen self-regulatory governance through the Broadcasting Advisory Council. The Broadcasting Advisory Council will be the body for content regulation.
- The Commerce Ministry's fifth LEADS report highlights 13 states and union territories, including Andhra Pradesh and Karnataka, as logistics achievers in 2023. The Ministry of Commerce and Industry released the fifth LEADS 2023 report highlighting the logistics performance of various states and union territories in India. The index serves as an important gauge to evaluate logistics services.
- Bangladesh team won the Under-19 Asia Cup title for the first time. Bangladesh won the title by defeating host UAE by 195 runs in the final match played in Dubai. Bangladesh's opening batsman Ashikur Rahman Shibli was the player of the match, who played a brilliant innings of 129 runs in the final
- Lok Sabha passed the Post Office Bill, 2023, ushering in a new era by replacing the old Indian Post Office Act of 1898. This would prove to be a milestone in legislative reform, but it has also given rise to concerns about privacy and misuse of government powers.
- RBI has tightened the norms for banks, non-banking financial companies and other lenders to invest in AIFs. This decision has been taken to curb the ever-increasing rise in stressed loans. The notification said that if the bank is unable to liquidate its investment within the specified time limit, it will have to make 100 percent provision on such investment.
