### History of February 13

- ♦ 1948 : Father of the Nation Mahatma Gandhi started a fast unto death.
- ◆ 1984 : Former Prime Minister Indira Gandhi inaugurated the Mazagon Dock in Mumbai for the Navy.
- ♦ 2001: The first unmanned spacecraft landed on the

- asteroid Eros in space.
- ♦ 1931 : New Delhi was declared the capital of India.
- ♦ 2010 : A bomb exploded in a bakery near the Jewish place of worship in Pune, Maharashtra, India's most famous state, in which about 17 people lost their lives.

### **Current Affairs Related to 13 February**

- The Union Cabinet approved extension of the scheme of sugar subsidy for Antyodaya Anna Yojana households distributed through the Public Distribution Scheme till March 31, 2026. Under this scheme, the Central Government provides a subsidy of Rs 18.50 per kg per month on sugar to the AAY families of the participating states. About 1.89 crore AAY families will benefit from this scheme. The Government will continue to provide subsidy to participating States for distribution of sugar to AAY families through PDS at the rate of one kilogram per family per month.
- A recent study in the United Kingdom suggests that Alzheimer's disease can spread from human to human. According to researchers, this occurred after a rare medical accident and the disease cannot be spread through everyday activities. This only happens when people have been accidentally vaccinated with human tissue extracts, which is a very rare and unusual situation.
- As the political scenario is getting ready for the 2024
  Lok Sabha elections in India, discussions related to
  the country's financial planning have come to the
  center stage. At the heart of this discussion is the
  difference between the interim budget and the full
  Union Budget, two important financial documents
  that guide the economic trajectory of the country.
- Naval Dockyard, Visakhapatnam witnessed an important occasion as Defense Minister Rajnath Singh presided over the commissioning ceremony of INS Sandhayak. The event marks a significant enhancement in the capabilities of the Indian Navy, strengthening its presence in the Indian Ocean region.
- Union Environment Minister Bhupendra Yadav has designated five wetlands in India as Ramsar sites. With this, the total number of wetlands in the country has now reached 80.
- According to the report of the Ministry of Commerce and Industry, India's core sector output growth fell to a 14-month low of 3.8% on an annual basis in December.

- Madhya Pradesh Chief Minister Mohan Yadav gave green signal to the Ujjain satellite campus of IIT Indore. Which is an important moment for education and skill development. With the approval of Union Education Minister Dharmendra Pradhan, the project promises substantial benefits for the sector. The approval of the Ujjain satellite campus of IIT Indore underlines the government's commitment to enhancing educational opportunities.
- The Finance Ministry has reduced the import duty on various components of mobile handsets from 15% to 10%. According to experts, the price of mobile phones will reduce by about 3.5 percent. Import duty has been reduced on components like battery cover, front cover, middle cover, main lens, back cover, GSM antenna/antenna of any technology etc. The government has not notified any date for implementing the lower charges.
- Four members of the Sixteenth Finance Commission were appointed by the government, including three whole-time members. Former Expenditure Secretary and member of the 15th Finance Commission A N Jha, former Special Secretary in the Department of Expenditure Annie George Mathew and Niranjan Rajadhyaksha, executive director of Earth Global, have been appointed as whole-time members of the SFC. He will decide the formula to share a major part of the Centre's tax revenue with the states for five years from financial year 2027.
- The World Health Organization has issued its first certification acknowledging progress in eliminating industrially produced and naturally occurring trans fatty acids. Five countries Denmark, Lithuania, Poland, Saudi Arabia and Thailand have been commended for their pioneering efforts in demonstrating effective policies and strong monitoring and enforcement mechanisms in their TFA elimination strategies.
- ♦ After the resignation of Hemant Soren, Champai Soren has been declared the next Chief Minister of Jharkhand.




