- ◆ The Reserve Bank of India gave final approval to Amazon Pay, the fintech arm of e-commerce major Amazon India, to operate as a payment aggregator. This will allow the company to further strengthen distribution channels and provide innovative solutions to merchants and customers across India, offering them a secure, convenient and rewarding digital payments experience.
- ◆ Rajeew Chandrashekar, Minister of State for Electronics and Information Technology, Skill Development and Entrepreneurship and Jal Shakti, released 'Investment Information and Consultancy Platform developed by Pagan Madras'. The platform acts as a one-stop shop for all stakeholders, from smooth access to a network of venture capitalists (VCs) and investors, to government approvals and many other intricacies of the business sector.
